

Surf Soccer Center Camp - Coronavirus/COVID-19 Release

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal, state and county health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Surf Soccer Center's COVID Camp has put in place preventative measures to reduce the spread of COVID-19 and related illnesses; however, cannot guarantee that you or your child(ren) will not become infected with COVID-19 and related illnesses. Further, training at Camp could increase your risk and your child(ren)'s risk of contracting COVID-19 and related illnesses.

By signing this agreement I acknowledge the contagious nature of COVID-19 and related illnesses and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 and related illnesses by training at the Surf Soccer Center Camp. Such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 and related illnesses at Surf Soccer Center Camp may result from the actions, omissions, or negligence of myself and others, including, but not limited to, San Jose Surf Soccer Center Camp employees, volunteers, and program participants and their families.

I voluntarily agree to assume all the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Surf Soccer Center Camp, or participation in Surf Soccer Center Camp ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge and hold harmless Surf Soccer Center, its employees, agents and representatives, of and from the Claims including all liabilities, claims actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Surf Soccer Center, its employees, agents, and representatives, whether a COVID-19 and related illnesses infection occurs before during, or after participation in any Surf Soccer Center Camp program.
